Anneuxre- I Terms and condition of Disposal of Scrap

- 1. Rates should be quoted for the entire stacked materials lying in the parking area of GST Bhawan, Kedar Road, Guwahati-781001. The scrap includes scraps of old and damaged Almirah, Racks, Chair and Tables etc.
- 2. Rates should be quoted Rs/per kg basis. The scrap material shall be weighed before highest successful bidder.
- 3. Auction bid to be submitted in sealed envelope super-scribing on the top "Auction sale of scrap material in GST office". The format of financial bid is enclosed with terms and conditions. The Auction bid can be submitted to the PRO, Room NO. 101, GST Bhawan, Kedar Road, Fancy Bazar, Guwahati by 16.07.2019 at 1100 hrs.
- 4. The scrap is available at following address and can be inspected on any working day before auctioning with prior intimation to the PRO, Room NO. 101. GST Bhawan, Kedar Road, Fancy Bazar, Guwahati-781001. Phone N.- 0361-2972057.
- 5. Rates are to be quoted in Rupees / kg in the enclosed finance bid form.
- 6. The entire scrap is to be disposed off on "AS IS WHERE IS BASIS"
- 7. Purchase of scrap shall be awarded to the highest bidder of scrap.
- 8. Successful bidder shall be required to deposit Earnest Money (25 per cent of the bid value) immediately on the spot either in cash or Cheque drawn in favour of the office of the Commissioner, CGST, Guwahati; the balance amount shall be deposited before lifting the related material i.e. strictly within 2 days from the date of award of bid.
- 9. In case the highest bidder fails to deposit the full amount as per award of tender within prescribed time or fail to lift the scrap within 2 days (from the date of award of bid) after depositing the amount, the offer shall be cancelled and the money deposited would be forfeited. In such case next highest bidder shall be offered the lot at rates quoted by him and so on. The defaulting bidder shall have no claim /right in respect of property/amount.
- 10. Successful bidder will have to weigh the scrap at their own expenses. Labour for removal of scrap, weighing, loading/ unloading etc shall be arranged by the successful bidder. The material shall be lifted from the place of storage at the cost of the successful bidder.
- 11. Tax liability, if any, shall be borne by the successful bidder.
- 12. Use of unethical practices during the process shall lead to rejection of concerned bid.
- 13. The office of the Commissioner, CGST, Guwahati reserves the right to accept or reject summarily any or all tenders as a whole or any part thereof, without assigning any reason whatsoever.
