It is proposed for disposal of the following vehicle of this office i.e. Directorate of Revenue Intelligence, Guwahati Regional Unit on "as is where is" basis:



Accordingly, sealed quotations are invited for the disposal of above mentioned vehicle on the terms and conditions mentioned below. In case any party is interested in buying the above mentioned vehicle, he/she may submit his/her quotation in the enclosed proforma. All concerned are required to quote their highest offer/price for the vehicle, the particulars of which are given in the proforma.

The quotation should be addressed to the Assistant Director, DRI, Guwahati Regional Unit, Guwahati and is to be dropped in the Tender Box kept at the Office of the Assistant Director, Directorate of Revenue Intelligence, Guwahati Regional Unit, Krishnanagar, Chandmari, Guwahati -781 003 on or before **06.04.2018 (within 17.00 hrs.)**. The vehicle will be available for inspection between 11 AM to 5 PM from **26.03.2018 up to 04.04.2018** (except holidays). The tender will be opened at about **14.00 hrs. on 09.04.2018** in the presence of the designated officer and if any of the bidders likes to participate in tender opening process, they may be present at the venue at aforesaid time."

The sale/disposal of the said vehicle will be governed by the following conditions:

1. The bidder is required to pay Earnest Money of Rs.5000/-.
2. Earnest Money is payable by means of Demand Draft drawn in favour of Assistant Director, DRI, Guwahati (payment by cheque or cash shall not be accepted).
3. Quotations received without demand draft towards Earnest Money will not be considered and shall not be accepted.
4. The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of Assistant Director, DRI, Guwahati within two working days of the acceptance of the bid.
5. The Earnest Money of the successful bidder/s will be released only after deposit of the sale proceeds. Earnest Money will not be adjusted as sale proceeds and will be forfeited if he/she fails to honour the bid.
6. Earnest Money will be refunded to unsuccessful bidders after deposit of sale proceeds by the successful bidder.
7. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/ Voters Identity Card/PAN/AADHAAR etc. in case of individual and Registration Certificate/PAN etc. in case of firms etc.)
8. The sold vehicle will be removed by the successful bidder within 48 hours of depositing the draft money at his/her own expense, and within 48 hrs. on intimation from this office.
9. The vehicle will be disposed of on "as is where is" basis and no guarantee for its worthiness or quality will be given by this Department.
10. The successful bidder shall be responsible for all action subsequent to disposal of the vehicle and this office will not be responsible for any omission/ commission on his part in this regard.
11. The bidders will not be allowed to withdraw their bids, failing which their earnest money will be forfeited.


