 - a. Duly filled **ATTESTATION FORM, IDENTITY CERTIFICATE, and Form of declaration regarding marital status.**
 - b. **CHARACTER CERTIFICATE** from three different Gazette Officers.
5. You are required to undergo the prescribed Medical examination and bring the Medical Certificate from a Medical Officer not below the rank of Civil Surgeon to submit at the time of your reporting. Certificate to be produced in triplicate.
6. Arrangement of stay will be made by the candidates. No travelling or other expenses will be paid by the Department. The whole process may take more than a day.
7. In the event of not reporting on the prescribed date, it will be presumed that you are not interested in accepting the offer of appointment in the department and your nomination will be treated as cancelled.
