### TERMS AND CONDITIONS FOR DISPOSAL VEHICLES AGAINST TENDER

1. Interested parties may submit their highest prices for the vehicle individually in a sealed cover latest by **2.00 PM on or before 30.08.2018**. The inner cover containing quotations and other relevant documents along with DD/Pay Order/ Banker's Cheque towards EMD should be sealed properly. The cover should be put in another Outer Cover and may be dropped in the Tender Box kept at the PRO's office at the 6<sup>th</sup> floor, Office of the Commissioner of Central Goods & Services Tax, Sethi Trust Building, Bhangagarh, GS Road, Guwahati-781005. Both the inner and the outer covers should be superscripted in bold Capital letter "**QUOTATIONS FOR DISPOSAL OF VEHICLE**".
2. The disposal of vehicle shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by this Department. The condition of the vehicles can be inspected physically between on any working day from 13.08.2018 to 24.08.2018 between 11.30AM to 4.00PM lying at the premises of Office of the Commissioner of Central Goods & Services Tax, Sethi Trust Building, Bhangagarh, G.S Road, Guwahati-781005.
3. The quotation should be accompanied by earnest money for Rs. 2,000/-. The earnest money can be deposited by bank Draft/ Banker's Cheque. The Bank Draft/ Banker's Cheque should be attached with the quotation letter failing which the quotation shall not be considered at all. If the highest tenderer/ successful tenderer accepted by the competent authority in this Department fail to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.

5. The successful bidder will be required to deposit the total bid amount by means of Challan in favour of Govt. of India within three working days of award of the contract.
6. EMD of the successful bidder will be released only after realization of sale proceeds amount. Earnest money Deposited of the bidders who fail to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this Department. EMD amount will not be adjusted in the Sale Amount accepted by the Department. EMD of successful bidder shall be released only after successful completion of the sale process.
7. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/ Voters Identity Card/ Passport in case of individual and Registration Certificate in case of firms etc.)
8. The sold vehicle will be removed by the successful bidder (s) within 48 hours of depositing the money at their own expenses. No assistance/ transportation will be provided by this Department. Permission to take out the disposed vehicles from this office premises will not be allowed on holidays, Saturdays and Sundays etc.

9. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
